Shareholders are also encouraged to provide an email address in order to receive electronic communication from the Company in the future.

Your proxy form must be received by 4.30pm (AEDT) on Tuesday, 26 November 2024, being not less than 48 hours before the commencement of the Meeting. Any proxy forms received after that time will not be valid for the Meeting.

Shareholders who attend the Meeting will also have the opportunity to submit questions during the Meeting.
